



## CREDIT VOUCHER TERMS AND CONDITIONS

Please see below all terms and conditions relating to the Credit Voucher for the Isuzu Corporate Triathlon Challenge powered by Algoa FM 2021:

- 1) The credit voucher can only be used for races hosted by IRONMAN South Africa for 2 years from race date (i.e until March 2023), thereafter the credit voucher will no longer be valid. This includes the IRONMAN African Championship, IRONMAN 70.3 South Africa, IRONMAN 70.3 Durban, 5150 Ekurhuleni, 5150 Bela Bela, 5150 Nelson Mandela Bay and Corporate Triathlon Challenge.
- 2) The credit voucher is based on the standard terms of entry as listed when registering online for the event. The terms of entry are available online when you register for the event.
- 3) Use of the credit voucher is offered on a first-come, first-served basis, up to such time as an event is sold out.
- 4) The voucher is limited and can be redeemed only from date of issue to 31 March 2023 where the registration has officially been opened in the years 2021, 2022 and/or by 31 March 2023, and only by following the general online registration process. The voucher neither grants any right to book in advance before the official registration has opened nor to register for any event without following the general online registration process or to register for an event already sold out.
- 5) The credit voucher and any remaining credit balance cannot be redeemed for cash.
- 6) The credit voucher may be used for more than one event depending on the credit available and entry fee applicable.
- 7) If there are price differences when booking a new event, the voucher holder must pay the residual value of a price exceeding the value of the voucher separately. If the voucher holder books an event where the price is less than the value of the voucher, the remaining value of the voucher can be used for special purchases associated with the event.
- 8) Athletes will be offered Event Credit to the value of their entry fee (including additional purchases such as FinisherPix packages). This will not apply to a donation made to the IRONMAN 4 the Kidz Charity and IRONMAN for Nature Charity.
- 9) The credit voucher is non transferrable.
- 10) It is not possible to defer the slot to another person.

### **Withdrawal & Transfer – Rules and Regulations:**

- Withdrawal requests must be received during the following time frames in order to be eligible for a partial refund:
  - until 45 days prior to race day: 25% refund of the entry fee
  - after 45 days to race day: no refund
- Transfer requests must be received 45 days prior to race day
